

CPCE Health Conference and CAHMR's Seminar Series

Under the Institutional Development Scheme (IDS) of the Research Grants Council, SPEED secured funding of over HK\$2.4 million to establish the Centre for Ageing and Healthcare Management Research (CAHMR) in December 2018, along with the organisation of the annual CPCE Health Conference and a series of research seminars and workshops on healthcare issues.

The Centre for Ageing and Healthcare Management Research (CAHMR) is led by Dr Ben Fong, Associate Division Head of the Division of Science, Engineering and Health Studies (SEHS) and Director of CAHMR, and supported by team members including Prof Peter P. Yuen, CPCE Dean; Prof Warren Chiu, CPCE Associate Dean (Quality Assurance); Dr Jack Lo, SPEED Director; Dr Artie Ng, SPEED Deputy Director; Dr Pimpong Tavitiyaman, Senior Lecturer and Associate Division Head of the Division of Business and Hospitality Management; Dr Simon Cheung, Dr Vincent Law and Dr Adam Wong, Senior Lecturers.

CPCE Health Conference 2020

CPCE 醫護研討會 2020

Themed "Ageing with Health and Dignity: Implications for Public Policy, Service Delivery, Workforce, Technology and Financing", the CPCE Health Conference 2020 was held by CAHMR, together with SPEED and HKCC, at PolyU Hung Hom Bay Campus on 13 January 2020. The Conference, held for the fifth consecutive year, was organised in collaboration with Hong Kong College of Community Health Practitioners, Hong Kong College of Health Service Executives, and Hong Kong College of Nursing and Health Care Management.

The Conference comprised seven keynote sessions, three plenary sessions, six parallel sessions with 31 presentations and 10 poster presentations, which facilitated valuable discussions among over 300 delegates and guest speakers in attendance. Academics and practitioners from countries and cities including Australia, Canada, the Chinese mainland, Hong Kong, Japan, Macau, Malaysia, South Korea, Thailand, and the United States of America were invited to deliver speeches that provided international insights from practices in different countries around this year's theme.

研討會共有七場主題會議及三場專題會議，並在六場平行會議中發表 31 場論文演說和 10 個海報主題匯報，逾 300 名參加者和嘉賓講者交流了寶貴的意見。來自澳洲、加拿大、中國內地、香港、日本、澳門、馬來西亞、韓國、泰國和美國等地的學者和專家剖析不同國家的醫療實務經驗，為是次會議的主題注入國際視野及創見。
